President's Report

What is a Listserv, Anyway?

You've probably noticed some changes with the Kitsap Bar Listserv. Earlier this year, the Bar Board took over the Listserv from Paul Fjelstad, who managed it for two-plus decades. Paul's work over the years can only be described as a labor of love for our local legal community and for now Past-President Lynn Fleischbein is carrying the baton, quite well I might add.

Kitsap Bar Association is a small town bar. Our Listserv posts important messages from the bench and from the WSBA, but we also continue to post will searches, office space vacancies and other less-than-official announcements, hopefully for the greater good. Recently we posted an announcement for a new online e-filing service. In hindsight, we might have clarified that the Bar wasn't endorsing the service but was just spreading the word of a viable alternative to in-person filing and messenger services.

Our biggest controversy since taking over the Listserv was when we posted a press release by the local NAACP chapter following the George Floyd killing. The Bar Board decided against editing it and we didn't give it any intro or editorial spin. But two of you responded with concerns that the Kitsap Bar Association had taken a political position. I'd like to share my exchange with one of the commenters. He or she shall remain anonymous, but I'd like to

commend this person's thoughtful treatment of the subject.





I'd like a detailed explanation for why Kitsap County Bar Association thinks its ListServ is the appropriate forum for Ms. Flood's "Press Release" as the local NAACP President. Does this mean that anyone can offer a "Press Release" or call to action or political statement and it will be circulated on the ListServ?

My Response:

Hi [Commenter],

Thank you for your comment. There's arguably a political element, i.e. the reference to establishing citizen review boards. We didn't intend to imply endorsement of such boards. However the overarching message is apolitical - that we as a culture and we as a community of lawyers can no longer tolerate these hate crimes committed against black people by police officers whom we entrust with our safety and protection. To date, the rule of law has failed to stop these crimes. The NAACP may be political in the eyes of many, but there will be no advancement against the tide of racially-motivated killings without having that organization at the table. So if there are future opportunities for lawyers to participate in constructive discussions about solutions at the community level, I expect to publicize those opportunities. I should note that the answer to your last question is "no" — Ms. Flood is a member of our county bar and I made a judgment call that was not intended to reflect on the merits of any arguably political proposal. I will keep your comment in mind and work to keep the politics to a minimum. Thanks again [Commenter].

His/her Response:

Neil:

I suggest you circulate a statement posing my question and your response. With regard to your response, I'd note that Ms. Flood was able to issue her Press Release to the Kitsap Sun this morning, albeit without the #BlackLivesMatter. I'd also note that Black Lives Matter is very much a political organization with local chapters and accepting donations.

To be clear - what happened to George Floyd was senseless and tragic and the officers involved need to be prosecuted to the fullest extent possible. Every, non-justified death of an unarmed suspect is hugely frustrating and heart breaking. White on black even more so because it just fuels racial tensions and everyone hopes and prays that there'll be no rioting.

Thank you.

With that, the Bar Board will be considering how we handle submissions to the ListServ.

Meanwhile, the Bar Board will host a Judicial Candidates forum for the Superior Court position on August 7 at 12 noon. We'll send out details soon, but this will be a hybrid meeting you can either attend via Zoom or in person at the County Commissioners' Chambers. Look for a new paradigm in which "not qualified" is no longer an option. Candidates will either be "qualified", "highly qualified" or you'll offer no opinion. More on this in a couple of weeks.

I can't believe it has been nearly 3 $\frac{1}{2}$ years since Darrell Uptegraft passed away. It doesn't take much imagination for many of us to hear his laugh and see his smile.

Darrell was raised in a number of states, as his dad was a refuge manager for the US Department of Fish & Wildlife. After a brief stint at Southern Illinois University, Darrell graduated with a Bachelor of Science degree from San Francisco State University. His next educational step brought him to Puget Sound School of Law in Tacoma. During law school Darrell clerked at McCluskey, Sells, Ryan, Olbertz & Haberly, joining the firm as an Associate in 1983. Toward the end of his career Darrell's practice was primarily as a plaintiff's Personal Injury lawyer.

He served as Kitsap County Bar President in 1999.

There are people who have many acquaintances and others who have deep, dear friends. Darrell had both. He was a good and respected attorney who represented his clients effectively. He was a determined advocate, but never mean. He was cordial with lawyers, staff, judges and clients. Darrell and Jim Sells could tell tales on each other one-after-the-other for hours. Jim Riehl and Darrell could make the other laugh out loud with just a look. Darrell was very human and humane.


Darrell had his share of enthusiasm – and mine. Nothing was done halfway. His obituary noted "Darrell's positive attitude and zest for life was infectious. He shared his love of golf, downhill skiing, fishing, gardening, and many adventures, with passion."

I recall Darrell telling the story of how "life is a game of inches."

Some roof work was needed at his house, so Darrell tied a safety rope around his waist and secured it to the bumper of his car. Suddenly, as he was working on the roof, the adrenaline started pumping when he heard the car door open and his wife get ready to head on an errand! Fortunately, he was able to get her attention before the car started moving.

In 2013 Darrell was diagnosed with ALS. I remember seeing him just after the diagnosis. He opined that the diagnosis was a mixed blessing. While his life expectancy was decreased, the doctor said he could "party like a rock star!" And I believe he did to the end.

Paul Fjelstad called Darrell "one of the most positive people I have ever known."

Dave Horton noted that Darrell was his first mentor and showed Dave that "no matter how stressful practicing law could be, it could be done with a smile, a laugh and kindness." Dave recalls from his interview with Darrell, "he obviously loved what he did, loved where he worked and loved the people he worked with."

Ashley Armstrong noted "Darrell was loved by his clients, a legacy we should all hope to leave behind."

Perhaps the best, and most accurate, five words to describe Darrell's life appeared at the end of his obituary: It was a good journey.

Job Title: Eviction Defense Contract Attorney (Temporary through June 30, 2021)

Kitsap Legal Services is seeking to hire one or more Contract Attorneys to Provide Eviction Defense services to low-income tenants in Kitsap County.

Funding for the position(s) is provided by a grant from the Washington Office of Civil Legal Aid (OCLA) to provide Eviction Defense to low-income tenants for evictions caused by COVID-19.

The contract attorney will provide direct representation to tenants facing eviction caused by COVID-19. Legal services may include, but are not limited to, client interviews, settlement negotiations, and court appearances.

Contract reimbursement is at \$100 per hour. Reimbursement will be made monthly.
